## Commission Meeting Minutes

A resolution was read granting retiring CLEST Agent Elizabeth Jones her duty weapon. A motion to grant the resolution was made by Commissioner Holladay and seconded by Commissioner Wingard. The vote was unanimous. After presentations of awards and plaques, a brief period of refreshments was enjoyed in honor of Ms. Jones.

A motion to accept the minutes of the last meetings was made by Commissioner Phillips and seconded by Commissioner Woods. Motion carried.

Director's Report. Director Cook reported that Detective Kevin Collins of the Pine Bluff Police Department was killed in the line of duty on October 5, 2020. She asked the Commission for a vote to award \$5,000 from the fallen officer's fund to Detective Collins' family. Commissioner Wingard made a motion to approve the award and was seconded by Commissioner Woods. Motion carried. Director Cook reported that she would be presenting the award to the officer's family in the coming days. Director Cook provided the Commission with an update on progress by the Law Enforcement Task Force and potential recommendations. She also thanked the CLEST staff for all the work they have put into assisting with the Task Force. She announced that the Department of Public Safety received grant funding to enhance the Department's website, which includes the CLEST website, and that updates would be coming soon. She reported that she attended the Back-the-Blue event and that the event was successful. Finally, she announced the retirement of Texarkana Police Chief Robert Harrison and his subsequent resignation from the Commission. Chief Percy Wilburn was elected to serve as Chairman and Mr. Doc Holladay was elected to fill the position of Vice Chairman.

Item I: Item one was to set the meeting dates for the upcoming year. Those dates were approved as January 14, 2021, April 8, 2021, July 8, 2021, and October 14, 2021 by a motion made by Commissioner Brown and seconded by Commissioner Rhoads. Motion carried.

Six Consent Agreements were presented: **Holden Lester, Christopher Brownlow, Tyler Lovell, Gary Miller, Daphne McCoy, and Bobby Anderson** were decertified by a motion made by Commissioner Rhoads and seconded by Commissioner Marsh. Motion carried. Two uncontested hearings were held: **Jeremy Covington and Freddy Williams**. Commissioner Woods made a motion to decertify both individuals and was seconded by Commissioner Phillips. Motion carried. Two contested hearings were held. After the testimony and evidence presented, a motion was made by Commissioner Woods and seconded by Commissioner Rhoads to decertify **Donald Hilsdon**. Motion carried. After the testimony and evidence presented, a motion was made not to decertify **Limon Williams**. Motion was seconded and carried. Limon Williams was not decertified. Attorney Charles Moulton served as Hearing Officer and Patricia Hendrix served as Court Reporter. A total of nine (9) decertifications.
