The meeting was called to order at 10:00 A. M.

A motion to accept the minutes of the last three meetings was made by Commissioner Marsh and seconded by Commissioner Wingard. Motion Carried.

At the completion of the agenda items, decertification hearings were held with Attorney Moulton presiding and Court Reporter Hendrix recording. Nine (9) uncontested hearings were held for **Jimmy Long, Rodney Davis, Kenya Campbell, Christopher Winfrey, Zachary English, Jalen West, Brooks Grabill, Gary Ladner and Calvin Salyers**. After hearing all evidence presented, a motion to decertify all nine was made by Commissioner Holladay and seconded by Commissioner Rhoads. Motion carried. A Hearing was held for **Jimmy Foreman**. After considering all evidence, a motion not to decertify was made by Commissioner Rhoads and was seconded by Commissioner Marsh. Motion carried with Commissioner Holladay recusing. A hearing was held for **Ronald Scott**. After considering all evidence, a motion not to decertify was made by Commissioner Rhoads and was seconded by Commissioner Woods. Motion carried. A hearing was held for **Don Paul Bales**. After considering all evidence, a motion not to decertify was made by Commissioner Rhoads and was seconded by Commissioner Marsh. Motion carried. Ten (10) were decertified and three (3) were not decertified.

Director's Report

Director Cook reported that she and Deputy Director Fred Weatherspoon attended a judiciary meeting on November 13 and that the DPS budget, which includes the CLEST budget, was approved by the legislature on November 17. She reported that the Governor's Task Force to Advance the State of Law Enforcement in Arkansas released its final report on December 17, 2020. She provided an update on the legislative session, including the sponsor that would likely run the bills associated with the Task Force report. Finally, she reported that she attended a law enforcement stakeholder meeting with the Arkansas Sheriff's Association on January 5, the Sharp County Jail opening on January 8, and a virtual meeting with the Municipal League on January 13.
