Commission Chairman Teague stated next up is division reports and first is the Fiscal Report.

# Fiscal Section – Karen Perry

Karen Perry stated good morning, Colonel, Commissioners, you have the April report in front of you, we have two more months to go in the Fiscal Year, so we are trying to get that closed out with no problems. Karen Perry stated we received a \$193,000.00 insurance check and that was a claim on the Roosevelt building we had some wind damage from July 2021, and they just now gave us the money for it. We are finished with the Fiscal Session, and we will now operate under Act 138 as of July 1. Out of that we received 50 new Corporal positions, and we received funding and appropriation for a new Quartermaster System. We are also working on our budget for FY25 which will start July 1. Karen Perry stated she would be happy to answer any questions.

Commissioner Allison asked did you say damage to the building in July 2021? Karen Perry stated yes sir 2021. Commissioner Allison stated that is amazing just now getting the proceeds. Commissioner Allison asked did we have to take legal action there. Karen Perry stated no, but we had to pay for all of the expenses up front and we are now getting the money back, just takes time.

Commissioner Reeves asked did you say that was State Farm? Karen Perry stated no, it is through the state insurance.

Commission Chairman Teague stated next is Administrative Services.

## Administrative Services – Major Roby Rhoads

Major Roby Rhoads stated Mr. Chairman, Commissioners, and Colonel Hagar good morning, the Administrative Services report for April includes the following personnel transactions, on the uniformed noncommissioned side we had three new hires, one promotion, two retirements, one voluntary resignation, and one transfer. The commissioned transactions included one new hire which was a reinstatement, two terminations, six transfers, and four promotions. We currently have five military deployments.

Major Roby Rhoads stated tomorrow we will wrap up the written and physical fitness testing for the 2024B Troop School and we are hopeful that we will have about 150 applicants make it through that process.

Major Roby Rhoads stated in our Wellness Unit, we had 27 visits last month and our nurse practitioner had 29 patients.

Major Roby Rhoads stated for the ASP Health Plan, the April paid claims were a little over \$1.5 million for an increase of \$647,781.00. Our fund balance was \$115,905 lower than last month and our total fund balance is \$11,330,223.00.

Commissioner Allison asked so when do we run out of money? Major Roby Rhoads stated when, hopefully never, I think we are doing okay.

Commission Chairman Teague stated the last graduation class, all of the class got deployed to their particular troops, is that going well, I am assuming they are assigned FTOs? Major Roby Rhoads stated they are taking a couple weeks off to burn some comp time and then report to their troop, and they will be in the FTO Program. Commission Chairman Teague stated so they are still on comp time off for now, most of them? Major Roby Rhoads stated yes sir. Commission Chairman Teague stated they needed some time off for what those guys go through and then they will be assigned an FTO, and how long is that? Major Roby Rhoads stated it could be fast tracked for a quicker process, but typically it is 12 weeks. Commissioner Chairman Teague asked how are the FTOs chosen? Major Roby Rhoads stated usually the Troop Commanders recommend them and then we will put a class on and train everybody in what we expect, everything that they need to know about how to train people, and how to document to keep us out of lawsuits. Major Roby Rhoads stated it is an in-depth program.

Commission Chairman Teague stated next is Crimes Against Children and this is one I wish was not on our agenda, not because we do not need to hear about it, but because we have to hear about it unfortunately.

Ms. Kalika Rogers stated good morning, Colonel, Chairman, and Commissioners, the CACD Hotline received 6,154 contacts in the month of April, with 2,465 of those being accepted for investigation. Ms. Rogers stated 10 of those were child deaths, we investigated three child deaths, we had five death assessments, and two of those were only documented, which there was no investigation. Ms. Rogers stated the CACD Investigations Unit accepted 526 new investigations and we closed 512 cases, with 148 of those being found true and that gave us a substantiation rate of 29% for the month of April.

Commission Chairman Teague stated next is Criminal Investigations.

Captain Randall Murphy stated good morning again, in April CID opened 160 cases that are broken down into broad categories; five robberies, one arson, three rapes, two human trafficking, 10 child pornography, 21 ADC cases, 28 narcotics, three officer involved shootings, and three homicides. Captain Murphy stated one of the cases involved Company A investigating a mass shooting incident in the city of Wynne that resulted in 10 victims being shot and two being run over by vehicles. Captain Murphy stated agents from various counties stayed in Wynne for four days with only a few hours' sleep each night. Over 100 people present during the shooting were interviewed, many claimed not to have seen anything while others admitted witnessing the event but refused to provide information. By the fourth day enough evidence had been gathered to lead to the arrest of four gang members who were charged with murder and given \$1 million cash bonds. Afterwards, I received calls from the Chief of Wynne and the Sheriff of Cross County praising the work of our agents and the leadership of Sergeant Jason Martin.

Commission Chairman Teague stated next is Highway Patrol Division.

Major Ron Casey stated in the Highway Patrol Division report for April we had 2,725 criminal arrests, 1,797 physical persons put in jail. Troopers arrested 295 DWIs, six DUIs, and issued 8,504 citations for hazardous violations and they had 19,850 total citations issued

for April. Troopers were in 49 pursuits and investigated 1248 crashes with 42 fatalities. Sadly, to say Troop C ended up having 10 fatals, six of those were killed in one vehicle crash. Fifteen stolen vehicles were recovered with an estimated value of \$290,000.00 and troopers drove 920,347 miles in April. CDL and DL testers gave 19,117 tests, dispatchers received 31,768 calls for service, and we had five aircraft missions. Major Casey stated I want to brag on the Highway Patrol, CID, Regulatory, and Training for helping us, we all know about the Eclipse event that took place on the 8<sup>th</sup>. We started a five-day saturation period from the 5 – 9 of April and Troopers issued 7,872 citations during that five-day period. These were saturations from every troop around the state. I do want to thank the other divisions for their help, they helped us with crashes, they helped us with roadblocks or whatever we needed so I do want to thank them for that help.

Commissioner Reeves stated all of those arrest will show up on, are they on this report right here all of these citations you mentioned during the saturation? Major Casey no sir, I gathered that off of activity that was sent into me, so I compiled it to add to this report.

Major Casey stated our Criminal Interstate Patrol seized 718 pounds of marijuana, 11.7 pounds of methamphetamine, <sup>1</sup>/<sub>2</sub> pound of cocaine, 404 pills, and 8.82 pounds of other drugs and I am really not sure what that is broken down to, and they confiscated \$94,640.00 cash.

Commissioner Allison stated looks like the drug interdiction people have been doing a really good job. Major Casey stated it is amazing and actually for the month of May in the June report is going to be outstanding too. Commissioner Allison stated I have been reading those clips that is a pretty outstanding job.

Commission Chairman Teague stated Regulatory and Building Operations Division, Captain Morgan.

Captain Dustin Morgan stated Mr. Chairman, Commissioners, Colonel Hagar good morning. During the month of April, the Identification Bureau and AFIS Section processed 24,328 civil background checks and 8,987 criminal fingerprint submissions. The Used Motor Vehicle Dealer Section processed 118 dealer applications. The PI Security Section processed 601 applications. The ASP Bomb Squad handled five separate explosive calls, and the Fire Investigators conducted five origin and cause investigations. Captain Morgan stated Corporal George Summerlin conducted 72 hours of accelerant training with his K9. Bomb Squad members accumulated 248 hours of explosives training throughout the month including recertification at the bomb school in Huntsville, Alabama.

#### NEW BUSINESS:

Commission Chairman Teague asked Colonel do we have any new business? Colonel Mike Hagar stated yes sir, I would ask that we move to Executive Session to consider personnel matters.

#### EXECUTIVE SESSION:

Commissioner Reeves stated I move that we retire into Executive Session to consider personnel matters. Commissioner Edwards seconded, and the motion passed. Commission Chairman Teague stated we have a motion and a second, all in favor, any opposed and the motion passed. The Commission went into Executive Session at 10:20 a.m.

Commission Chairman Teague called the meeting back to order at 11:17 a.m. and stated Colonel, I believe you have some recommendations.

Colonel Hagar stated yes sir, recommendations for promotion. The first position for consideration is Sergeant in the Highway Patrol Division, Troop G, and my recommendation is TFC Jackson Dorman. Commissioner Reeves made a motion to accept the recommendation that TFC Jackson Dorman be promoted to Sergeant in the Highway Patrol Division, Troop G. Commissioner Hinkle seconded the motion. Commission Chairman Teague stated we have a motion and a second, all in favor, I, and the motion passed.

Colonel Hagar stated the next one is Sergeant in the Criminal Investigation Division, Company B, my recommendation is Corporal Billy McCradic. Commissioner Akin made a motion that Corporal Billy McCradic be promoted to Sergeant in the Criminal Investigation Division, Company B. Commissioner Basore seconded the motion. Commission Chairman

Teague stated we have a motion to approve, and a second, all in favor, I, and the motion passed.

The last one for consideration is Captain in the Highway Patrol Division, Troop L, my recommendation is Lieutenant Jeffrey Plouch. Commissioner Basore made a motion that Lieutenant Jeffrey Plouch be promoted to Captain in the Highway Patrol Division, Troop L. Commissioner Hinkle seconded the motion. Commission Chairman Teague stated we have a motion to approve, and a second, all in favor, I, so ordered.

Colonel Hagar stated that is all I have Mr. Chairman. Commission Chairman Teague stated thank you Colonel. Commission Chairman Teague asked if there was any other business to come before the commission from any of the commissioners.
