## LARCENY / THEFT—HOW TO REPORT IT

ARKANSAS CRIMINAL CHARGES WITH MULTIPLE NIBRS OFFENSE CODES (HOW TO ENTER A CRIMINAL CHARGE WITH THE CORRECT NIBRS CODE.)

<u>Larceny/Theft Offenses</u>—The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another person.

**23A = Larceny (pick pocket)** - The theft of articles from another person's physical possession by stealth where the victim usually does not become immediately aware of the theft.

<u>23B = Larceny (purse snatching)</u> - The grabbing or snatching of a purse, handbag, etc. from the physical possession of another person.

<u>23C = Larceny (shoplifting)</u> - The theft, by someone other than an employee of the victim, of goods or merchandise exposed for sale.

**23D = Larceny (from building)** - A theft from within a building which is either open to the general public or where the offender has legal access.

<u>23E = Larceny (from coin operated machines/device)</u> - A theft from a machine or device which is operated or activated by the use of coins.

23F = Larceny (from motor vehicles) - The theft of articles from a motor vehicle, whether locked or unlocked.

<u>23G = Larceny (of motor vehicle parts and accessories)</u> - The theft of any party or accessory affixed to the interior or exterior of a motor vehicle in a manner which would make the item an attachment of the vehicle or neces-

- A single specific Charge Code may be tied to multiple NIBRS Codes pending the location or details of the crime.
- One example is A.C.A. §5-36-103 Theft of Property is tied to Pocket Picking, Purse Snatching, From A Building, From Motor Vehicle, All Other and ETC.
